Make sure all addresses and phone numbers are complete. This application is for the **130 HOUR FULL ACADEMY (TFA)** course only. It must be received in our office on or before 21 days prior to the course start date. Applications must be accompanied by at least the deposit of \$500.00 (non-refundable but transferable) to secure a position in the class. All tuition is due in full (\$4950.00) on or before 7 days prior to the start date of the class unless prior arrangements are made. Persons applying for the "Buddy" discount plan must make notification at the time of registration. This class is limited to 24 students each session. It is on a first come first serve basis.

Applicants will be applying for security sensitive positions, if not already employed. Attach copies of all requested information and submit with the application. Students may at some point, be required to submit to a background investigation and drug screen, by their potential employers. If you have been arrested, be as truthful and complete as possible. This does not mean that you will not be accepted into the class, if the offense is a class B Misdemeanor or above. However, the severity of the offense' disposition and time frame will be considered. Class C Misdemeanors or juvenile infractions are not considered.

TAACO TFA FACILITY RULES & GUIDELINES

The Staff of the Texas Academy of Animal Control Officers would like to welcome you to the premier humane law enforcement, animal care and control Full Academy training program.

You will be checking in on February 04, 2018 at Ramada Inn here in Giddings right after orientation. Orientation will start at 2:00 pm at the TAACO training academy, located at 332 E. Cuero Street Giddings, TX 78942. Class will start 8:30 am Monday morning, February 06, 2017. Rooms at the Ramada Inn are double occupancy unless student request a single, at their expense. (\$560.00 additional for a private room). Males and females will room separately, unless requested otherwise (dating or married couples). In addition, we are not guaranteed rooms on weekends, so if you will be staying here throughout the length of the course, notify us as soon as you know. The other days (Thurs-Sat) will be added to the already calculated tuition cost (\$630.00).

The class will run from February 05 to March 02, 2018.

Below is a list of personal items you will need to have with you upon arrival:

- 1. Personal toiletries and grooming supplies.
- 2. Modest, street clothes and swim wear to wear during off time.
- 3. At least 2 Pair of BLACK uniform type pants.

(These can be found at almost any police/security supply store. Also check at Academy Store. It is highly recommended that you wash all new items in cold water with 2 cups of vinegar added the first washing, to prevent fading. It is also suggested you then take them and have them professionally starched and pressed to set the color and crease. (Dickey Brand is acceptable as well)

- 4. 3 BLACK CREW NECK TEE/ UNDER SHIRTS.
- 5. 5 pair BLACK ATHLETIC SOCKS
- 6. 1 BLACK 1 1/2" SMOOTH/PLAIN LEATHER BELT W/ SILVER BUCKLE
- 7. 1 pair BLACK TACTICAL BOOTS (NON SLIP SOLE)

(Example: Lace-UP/ Zipper - ACADEMY SPORTS BATES BRAND #E02700)

8. Uniform shirts will be furnished and issued at orientation.

Students will be expected to always act in an adult and respectful manner while attending or representing the Academy. Those failing to do so are subject to dismissal from the program with no recourse. You are training to be a professional Humane Law Enforcement Officer, we expect you to conduct yourself as such.

TAACO TFA Rules & Guidelines

NO JEWELRY, ear rings or piercings of any kind are allowed while in uniform. This is for your safety and to ensure you are portraying a positive, professional image of Animal Control Officers. In addition, tattoos of questionable taste will be required to be covered.

<u>Males</u> are required to have their hair cut/styled in a manner appropriate for the profession of law enforcement: above the ears and collar. It is recommended that <u>Females</u> wear their hair short (collar length or less) or in a pony tail during class, this too, is a health & safety precaution. No facial hair except for groomed mustaches is allowed.

Uniforms shall always be worn in a neat and professional manner at all times during class and Academy functions, unless otherwise instructed. Pants must fit properly and be worn at the waist with a belt.

Personal Protection Equipment will be required at times during certain segments of class. (Required equipment such as: gowns, coveralls, aspirators, gloves, safety shield/glasses or goggles will all be furnished by the Academy.)

In accordance with the Texas Education Code, the possession and use of Tobacco products on the premises of an educational facility are prohibited. However, since TAACO is a private facility a special area is posted for smoking at various times for those <u>of age to legally posses and use tobacco (18 years of age)</u>. However we strongly urge students not to use tobacco products anytime. Animal Control can be an extremely physically demanding job and it is in one's best interest to be physically fit.

Possession and/or the use of drugs or alcohol of any kind are strictly prohibited at the TAACO facility. Those of age 21 or older may consume the alcoholic beverage of their choice away from the facility, and after the course is completed for the day. However, the TAACO staff does not recommend or condone alcohol consumption. You are here to learn, not to party. Purchasing and/or consuming alcohol in uniform is strictly forbidden at any time.

Students are expected to be in their seats and ready for class PROMPTLY at 08:30 hours each day, except when directed otherwise.

There will be at least 2 off facility field trips during the course. Students may want to bring a small ice chest or back pack.

Parents and family members are welcome to visit anytime. However, we would appreciate the visits to be on Wednesday afternoons.

We are excited about having each of you in the TAACO TFA training course. You are embarking on an adventure of a life-time, in preparing to enter a profession that very few will attempt and even fewer will remain in. It takes a very special person to do animal care & control and/or humane law enforcement. We thank you in advance for your efforts and choosing TAACO to provide you with the most progressive and professional training available. You will be at the top of the hiring lists upon graduation from the Texas Academy of Animal Control Officer TFA. We will assist you in every way to see you become employed in your chosen field.

ACCEPTABLE METHOD OF TUITION PAYMENT

OPTION 1 Cash, Check, Money Order or Credit Card. If full payment is made at

one time with the application, this is eligible for the paid in full

discount of \$125.00.

OPTION 2 All student loans, personal loans, grants or scholarships.

If full payment is made at one time or in 2 payments (\$500 deposit & then remaining balance) this is eligible for the paid early discount of

\$125.00.

Unfortunately, TAACO can not be issued a Federal School Number, because the TFA class is less than 600 clock hours. <u>Therefore, we are unable to accept FASFA and PAL Grant funding</u>. Some grants maybe available though the Texas Workforce Commission (WIA) program. Each person would be required to individually apply through their local TWC office.

OPTION 3 Tuition payment or partial payment from The Veterans Administration,

from the Texas Department of Assistive and Rehabilitative Services or The Texas Workforce Commission may be available to students who

qualify.

OPTION 4 Tuition in ONE full payment & 30 days prior to the first day of class.

This option is eligible for the early registration discount of \$250.00.

TAACO also offers a \$100.00 "BUDDY" reimbursement for any person that registers with or refers someone that registers for the same session of the TFA.

The TFA course is available without lodging also, deduct \$250.00 for no lodging.

If you desire a private room, the additional charge would be \$560.00.

If you need weekend lodging, the additional charge would be \$630.00.
